

REGULATIONS

I GENERAL PROVISIONS

1. These Regulations („the Regulations”) specify the terms according to which a draw making it possible to conclude a sales agreement for a brand of adidas footwear, the model adidas + KANYE WEST – YEEZY BOOST 350 V2 „SEMI FROZEN YELLOW/GREY STEEL/RED” – model, takes place between Participants and the Organizer (the Draw), and the rights and obligations of the Organizer and Participants in the Draw as well.
2. The Organizer is (“the Organizer”) SZOPEX-DUTKIEWICZ sp. z o.o. sp. k. with the registered office in Olsztyn (10-166) at ul. Marka Kotańskiego 6 (NCR 0000724788), the owner of a stationary and Internet chain store the brand of Warsaw Sneaker Store Chmielna 20 (<https://www.chmielna20.pl>).
3. The Draw whose terms have been specified in the Regulations is not a game of chance, a lottery, a mutual bet, or a promotional lottery whose result depends on chance within the meaning of the Gambling Act of 19 November 2009 (Journal of Laws of 2009 no. 201 item 1540, as amended). In particular, a Participant does not obtain any material or money prizes as a result of the draw.

II. THE RULES OF PARTICIPATING IN THE DRAW

4. The aim of the Draw is to make it possible for the selected Participants to purchase the footwear of YEEZY BOOST 350 V2 „SEMI FROZEN YELLOW/GREY STEEL/RED”.
5. A Participant of the Draw (“a Participant”) can be a natural person being a consumer within the meaning of art. 221 of the Civil Code that has met the terms that are specified in para. 6 and 7, and is a subscriber of the Organizer’s newsletter.
6. A Participant can report his/her willingness to take part in the Draw from 07.12.2018 since 2.00pm. Till 13.12.2018 till 11am. (“the Application Period”). The applications sent after the expiration of the Application Period will not be considered.
7. In order to take part in the Draw, one ought to fill out the application on the website - <http://yeezy.chmielna20.pl>
8. The Draw will take place on 14.12.2018.
9. The announcement of the Draw’s results will take place on 14.12.2018 by notifying the selected people by the Organizer with the help of the email.
10. In the case of being drawn, a Participant is entitled to conclude a sales agreement with the Organizer on 14.12.2018 within 60 minutes from the moment of receiving a purchase link. After the expiration of this term, this right expires. This right also expires, when the amount due to the Organizer resulting from the concluded sales agreement is not booked on the bank account indicated to the Participant, or if the Organizer does not receive a payment for the goods sent to the Participant till up to 2 hours from the time take a order.

III. COMPLAINTS

11. A Participant has the right to file a complaint in the case of an incompliance of carrying out the Draw with the Regulations. Complaints can be sent in writing only to the Organizer’s address: SZOPEX- DUTKIEWICZ sp. z o.o. sp. k. 10-166 Olsztyn, ul. Marka Kotańskiego 6, with the annotation „Complaint-Draw”
12. Filing a complaint ought to include a precise description of a complaint and a Participant’s data that are necessary for replying him/her.
13. A Participant has the right to file a complaint from the day of publishing the Regulations, and within 14 calendar days from the day of announcing the results. Complaints will be considered within 10 calendar days from the day of receiving them.
14. A reply to complaints will be sent by mail to the address provided by a Participant.
15. The Organizer reserves the right to refuse to consider a complaint in the case of filing a complaint after the deadline, filing a complaint to a wrong address, and in the case of a

Participant not giving contact data making it possible to send the reply.

IV. PERSONAL DATA PROTECTION

16. The Administrator of Participants' Personal Data is SZOPEX-DUTKIEWICZ sp. z o.o. sp.k. Olsztyn (10-166) at ul. Marka Kotańskiego 6 (NCR 0000724788). The Participants' Personal Data are subject to protection in accordance with Personal Data Protection Act of 29 August 1997 (Journal of laws of 2002, no. 101, item 926, as amended).

17. Participants' personal data are processed in order to conduct and implement the draw. Giving personal data is voluntary but necessary for the aims connected with the participation in the Competition.

18. Participants have the right to access their data and to correct them in accordance with Personal Data Protection Act of 29 August 1997 (Journal of laws of 2002, no. 101, item 926, as amended).
